# 1. SELL THE PRODUCT

We buy our products at wholesale - which is 50% off the retail price! We can then turn around and sell it to our customers for double the price we paid for it.

# **CONSULTANT COMMISSIONS**

- 4% Commission for 1-4 active personal team members
- \$50 Bonuses starting with the 4<sup>th</sup> personal qualified team member
- 9% Commission for 5 or more personal active team members
- 13% Commission when 5 or more personal active team members place minimum \$200 wholesale orders during one month (plus your own \$600 wholesale order)

# **DIRECTOR COMMISSIONS**

- 26% Commission for your own personal team members
- 13% Commission for all other unit wholesale orders that are placed during a month
- 10% Unlimited Bonus is paid to directors based on entire unit's monthly wholesale production
- Director receives \$100 for every new personal qualified team member
- Director receives \$300 bonus or \$500 bonus monthly when unit meets a certain goal
- Director receives Star Bonuses each quarter when unit meets a goal
- Director receives Annual Wellness Bonus (\$750-\$1800/year)
- Director receives \$1000 bonus when she achieves a higher Circle of Achievement or Excellence than previous year and every time she qualifies/requalifies for the Pink Cadillac
- New Directors receive \$1000 bonus when they complete On the Write Track, Fabulous 50s Club and Honors Society in their first year as a Director.
- This is not a pyramid company. All commissions are paid directly from Mary Kay Inc. to the consultant or director in the form of a bonus check. It is never taken out of a team member's pocket and does not ever influence a team member's income. These commissions are paid on a monthly basis for as long as the recruit and recruiter are active (order \$200 wholesale once every 3 months) with the company.
